

CHLOE GRAFTIAUX PASSION TOGETHER

RULES for 2013

1. Article 1 : Purpose

The financial assistance provided by Chloé Graftiaux Passion Together is aimed at supporting individual or group initiatives that seek to share a passion for mountain sports, climbing or mountain rescue, with young people in difficult circumstances (handicap, illness, social difficulties...), here or abroad.

2. Article 2 : Candidates

Chloé Graftiaux Passion Together targets preferably projects aimed at young people in the 18 – 30 year old age range, but the project leaders may be older. Certain projects that are aimed at younger participants, may also be supported.

3. Article 3 : Inscription

To be eligible, project submissions must be :

- Presented using the application form : the form can be downloaded from the website (www.chloegraftiaux.com) and can either be sent by post to the association (2 copies required) or by email to info@chloegraftiaux-passion-together.com
- Written in French, English or Dutch
- Complete with annexes
- Received by the association before April 15 2013

Project submissions will not be returned.

4. Article 4 : Project eligibility

Candidates must present a subject that fits this year's theme, i.e. sharing in a concrete manner, a passion for mountain sports, climbing or mountain rescue, with young people in difficult circumstances (handicap, illness, social problems...). The youngsters who will benefit from the project, may be here or abroad. The group which is carrying the project may itself be made up of young people who themselves experience difficulties. The project may be part of a wider programme on a related subject.

The jury will assess the project according to the following criteria :

- Project pertinence with regards to the funding grant's objectives
- Project feasibility and interest
- Structured project organisation
- Participants' spirit of innovation, of initiative and their experience
- Project members' motivation and commitment
- Technical skills and training
- Knowledge and respect of local culture (for foreign projects)
- Existence of partnerships
- Project communication

5. Article 5 : Ineligibility

Project submissions will be rejected if they are :

- Incomplete
- Submitted after the April 15 2013 deadline
- Incompatible with the grant's theme or the eligibility criteria

6. Article 6 : Partnerships

Chloé Graftiaux Passion Together will in no case cover the total budget.

7. Article 7 : Timings

The 2013 Chloé Graftiaux Passion Together grant will support projects during 2013. Projects may, however, have timescales which stretch beyond this date.

The final decision will be taken by June 1st 2013 at the latest.

8. Article 8 : Responsibility

The project representative assumes total responsibility for his or her organisation.

9. Article 9 : Jury

The jury is made up of 2 founder members of the Chloé Graftiaux Passion Together association, along with representatives from the mountain sports community. The jury's decision is final. The selection process will not be made public.

10. Article 10 : Notification

Candidates will receive notification that their submission has been received, and will be informed of the jury's decision.

11. Article 11 : Intellectual property rights

The « Chloé Graftiaux Passion Together » asbl cannot be held responsible for divulging and confidential information included in the project submissions. The asbl will not use the ideas submitted by the projects, and will not communicate them to any third parties with that intent.

12. Article 12 : Contractual undertaking

When the prize is announced, the winning project's representative will sign a contractual undertaking concerning the effective use of the « Chloé Graftiaux Passion Together » grant, the timescales for project completion, and a summary of the project once completed. Winners must sign a receipt for the amount awarded, as well as this document.

13. Article 13 : Project monitoring

The winners undertake to

- Provide details of project progress on request
- Provide a detailed report, in press article form. The report should include details concerning : achievement of objectives, location, dates, names of the young people who benefit from the project, anecdotes, photos ...
- Be available and present for a project presentation event (conference or meeting, including if possible a small video presentation). The event date will be agreed between the organisation and the winners.

The detailed report (press article) and photos will be presented on the www.chloegraftiaux.com website and via other media as deemed appropriate by « Chloé Graftiaux Passion Together » (e.g : Club Alpin Belge magazine, Belclimb, Kairn, ...)

14. Article 14 : Non-realisation

The funding grant is awarded on condition of effective completion of an individual or group project. The candidate(s) who take part, undertake to complete the project if they are selected by the jury. If the project is abandoned, the winner(s) undertake(s) to reimburse the entire grant amount.

15. Article 15 : Project funding

The grant amount will be awarded after the partnership contract has been signed and the provisional project budget has been validated. The grant is awarded to defray expenses incurred by the project but may in no way be considered as fees or payment for services.

16. Article 16 : Payment

The grant may be disbursed in two fractioned payments, subject to the signature of this document and the award payment receipt form.

17. Article 17 : Environmental good practice

The Chloé Graftiaux Passion Together grant winners are encouraged not to leave litter or other material in the countryside. They are also encouraged to respect the environment when preparing their project.
